

Kohl's Proprietary Brand Protection Policy & Sell Off/Redistribution Form

Kohl's Proprietary Brand Protection Policy

(the "Policy") is in place to protect Kohl's Proprietary Brands and Trademarks (collectively "Kohl's Brands")

- The unauthorized sale of any products under Kohl's Brands constitutes trademark infringement.
 - A list of the trademarks protecting Kohl's Brands can be found on page 2 of this Policy.
 - Please contact Kohl's Quality Assurance Team with any questions – quality.assurance@kohls.com
- Approved vendors and factories requesting permission from Kohl's to sell off or redistribute products developed or produced for Kohl's Brands must comply with the requirements set forth in this Policy.
- This Policy expressly applies in the following scenarios relating to products for Kohl's Brands:
 - Cancelled Purchase Orders
 - Returns to Vendor ("RTV")
 - Factory Left-overs (e.g., overruns, defective products not meeting Kohl's quality expectations, etc.)
- Kohl's **does not permit** any products for Kohl's Brands to be sold off or redistributed:
 - **Within North America** (including the U.S. and its Territories, Canada and Mexico);
 - **Online** (including, but not limited to, internet sales, mobile applications, etc.); and
 - **During the selling season the product was developed or produced for Kohl's Brands.**
 - For example, products developed for Spring 2026 may not be sold off or redistributed until Fall 2026 (i.e., 6 months after the Spring selling season).
- Kohl's expressly reserves the right to request additional information for any request under this Policy.
- All requests will be approved or denied in Kohl's sole discretion.
- Kohl's EVP, Global Sourcing and Product Services and GMMs must approve any exception to this Policy.

Approved requests for sell-off or redistribution outside of North America must comply with the following requirements:

1. All **main labels, supplemental labels** (other than the care/content label), hangtags and other price ticketing must be removed or obliterated. This includes any/all labeling references to Kohl's or Kohl's Brands.
2. Products with **main labels** imprinted directly onto the product such as inside a garment at the back neck, appliqued, embroidered or sewn on, or any Kohl's identification that cannot be removed or obliterated (e.g., rivets, snaps, etc.) without destroying the product cannot be sold off or redistributed.
3. **Kohl's RN# (73277)** must be made illegible with permanent black marker, a heat seal, or removal of the label.
4. Kohl's vendor/factory must provide Kohl's Quality Assurance team with the names and addresses of all approved salvagers, retailers and/or resellers who purchase the products (see page 3).
5. Kohl's vendor/factory must obtain written confirmation from all approved salvagers, retailers and/or resellers that all third-parties shall comply with this Policy.
6. Kohl's vendor/factory must show proof of de-labeling/de-ticketing upon request from Kohl's. This could include documentation, images or the return of all labels & tickets with Kohl's Brands.

Definitions:

- **Main Labels** will always include Kohl's name and/or Kohl's Brands
- **Supplemental Labels** may include Kohl's name and/or Kohl's Brands in addition to product feature identification.
