- Compliance fees may increase or decrease based on a vendor's scorecard performance Vendors with "A" or "B" level performances will see decreased compliance fees, for rule codes listed below; vendors with "D" or "F" level performances will see increased compliance fees, for rule codes listed below

Fill Rate Process

Domestic Fill Rate

- Domestic vendors must meet a 97% (at a SKU per PO level) fill rate for all PO types
- Fill Rate is assessed based on the PO start ship date; changes made on or after the PO start ship does not exempt from Fill Rate detection
- Violations will be issued for POs not meeting the requirements, at \$150 plus 10% of unfulfilled units cost
- Disputes will not be accepted for fill rate violations that result from split/late shipments

Fill Rate Replenishment ("IN" PO Type)

- After an Inforem PO's SKU level detection & violation occurs, we will follow with 6 weeks of zeroed chargebacks for that SKU
- The chargeback will begin again at the SKU level on the 7th week

Transportation Compliance Notifications

Email Notification of Transportation Compliance Charges

- Vendors may receive Transportation charge notifications through Kohl's normal compliance process that were previously sent via post-audit notifications. The charge notifications are related to the violations listed below:
 - Late shipments
 - o Failure to consolidate
 - Consecutive day shipments
 - Back order freight
- Kohl's intent is to minimize, but not completely eliminate, post-audit detections through this process. Typical notifications will be transmitted between 60 and 90 days of violation event(s). Vendors will continue to see post-audit notifications / detections

Compliance Communication Information

Dispute Instructions

- Disputes must be submitted within 60 days of the detection date via the Compliance Portal (Traverse Systems) which can be accessed on-line at the following address: https://kss.traversesystems.com/#/login
- In the event that a dispute is returned, the returned dispute must be submitted, with the necessary documentation/evidence requested, within 30 days of receiving the returned dispute; returned disputes will be denied after 30 days if no action is taken
- Additional disputes, beyond the initial dispute made in the Compliance Portal (see point above) will not be permitted; all evidence for a dispute must be included on the initial dispute

Exemptions

- Beginning December 1, 2025, all exemptions related to the following categories will be removed entirely:
 - Packing accuracy
 - Ticketing
 - Carton utilization and labeling
 - Store and eFC polybags and gum labels
 - Routing
 - ASN

- Requests for any future exemptions to a rule must be submitted via the following Google Exemption Request Form for review:
 - <u>If approved</u> by Kohl's, exemptions submitted through the form are valid for a maximum of one year or less if noted in the approval
 - A new request should be submitted at least 30 days prior to a current exemption expiration date in order to discuss a renewal
