Refer to the violation number on the notification  <b>EXAMPLE: 4123456</b>	Notifications are e-mailed to our vendors daily to inform them that a violation has been issued. It will contain detailed error information for all issues (non- chargeable and chargeable) that were approved the previous day.		
Claims <b>starting</b> with "7090"  <b>EXAMPLE: 7090123456</b>	Statements are e-mailed to our vendors at the end of each week. They include a summary of violation charges and credits from the period. One master charge number will be issued for the period, reducing the number of accounting transactions relative to these issues.		
Claims <b>starting</b> with "R", "1013", "1014" and state: Collect PGM or Commercial Zone  <b>EXAMPLE: 1013123456</b>	Kohl's routing may combine shipments from multiple vendors within the Los Angeles, New York and New Jersey commercial zones to create full truckload shipments shipping direct to the Kohl's Distribution Center. Commercial zone multi-stops are dependent upon volume, shipment dates, and locations. Vendors will receive a separate debit memorandum from Kohl's stating Multi-Stop/Commercial Zone Routing Fee in lieu of the standard pick-up charges from the consolidator. The commercial zone fee offsets costs of out of route miles, stop-off charges and labor incurred to conduct commercial zone multi- stops.
