July 2018 TO: Kohl's Merchandise Vendors RE: Merchandise with Legally Regulated Components GOAL Procurement of Safety Data Sheets (SDS) and Product Profiling

Overview

Kohl's is partnering with UL/WERCS (WERCSmart) to provide product profiling and safety data sheet management services for all Kohl's merchandise which contain legally regulated components. Kohl's requires product information (in the form of the SDS) from vendors on all merchandise with regulated components to determine whether they may trigger compliance obligations (transportation, handling, and disposal). We require this information on the majority of non-apparel items.

Kohl's Authorization

Kohl's has authorized UL/WERCS to act as its designated representative to acquire merchandise information and SDS documents on behalf of Kohl's. In partnership with UL/WERCS and to support our compliance with safety and environmental regulations, Kohl's has established a centralized SDS repository located at UL/WERCS.

UL WERCSmart Solution

With WERCSmart, our valued vendors can streamline product submissions with the highest standards of confidentiality and service. Kohl's is requiring all merchandise vendors* to create an account or, for existing users, to log into your WERCSmart account to register your Kohl's merchandise included in the categories listed below. This includes new and existing merchandise sold to Kohl's. The centralized SDS management program will significantly reduce the workload of distributing duplicate copies of SDS throughout Kohl's organization.

WERCSmart Registration Deadline: September 1, 2018

Failure to register by the deadline above will result in a compliance charge of \$1,000 per month until registered.

Business Rule: All merchandise with regulated components sold to Kohl's must be registered on WERCSmart within 30 days of Kohl's Purchase Order receipt or be subject to a penalty

Product categories requiring registration:

Chemical-containing products

- Any product advertised or labeled to kill, repel, or prevent the growth of any living organism (e.g., anti-microbial products, pesticides and other products regulated under the Federal Insecticide, Fungicide, and Rodenticide Act)
- Products containing a powder, gel, paste, liquid, or gas not intended for human consumption
- Products intended for human inhalation, consumption, or absorption: lozenges, pills or capsules (e.g., pain reliever, vitamins, water pills)
- Medicated swabs, wipes, bandages and patches (heated and/or medicated)
- Energy bars, diet supplements, vitamin drinks, over-the-counter medications/supplements
- Liquids (e.g., soap, shampoo, cough medicine, eye drops, ear drops, nasal spray and inhalers)
- Medicated shampoos, gums, ointments and creams, including suntan lotion
- Lip balm, lip creams and petroleum jelly
- Equipment sold with chemicals (e.g., vaporizer sold with medication, air fresheners, and gel shoe inserts)

Aerosols (e.g., any product that contains a compressed gas or propellant

Batteries (e.g., all batteries, any product that contains a battery)

Electronics (e.g., any product that contains a circuit board, blinking lights or making sounds)

Fluorescent Lamps (e.g., Halogen lamps, High-Intensity Discharge (HID) lamps)

*"All merchandise vendors" is defined as any vendor who supplies merchandise with regulated components as listed above.

Supply Chain Hazardous Materials Policy for Merchandise Vendors

Policy Overview

Kohl's requires compliance with transportation and environmental hazardous materials regulations throughout the supply chain. Compliance is a team effort and Kohl's Business Partners play a key role.

Transportation of hazardous materials is regulated by various governing bodies including the US Department of Transportation (US DOT), International Maritime Dangerous Goods (IMDG), International Air Transport Association (IATA), and International Civil Aviation Organization (ICAO).

When do Hazmat transportation regulations apply?

- Forward logistics- includes product moving through supply chain to stores
- E-commerce fulfillment via shipping customer orders
- Reverse logistics- includes product moving back through supply chain from store to distribution center, recycling, or disposal

The US Environmental Protection Agency (US EPA) and individual State regulations include disposal restrictions related to hazardous materials. The regulations apply to merchandise that is recycled or disposed.

Kohl's Vendor Requirements:

- Help achieve compliance with transportation and environmental hazardous materials regulations
- Identify product that is deemed hazardous material and properly notify Kohl's
- Prior to PO issuance, complete product profiling using UL WERCSmart portal http://www.ulwercsmart.com/subscription-options.php
- Identify the material and provide information on the required transportation information via safety data sheets (SDS) to the Transportation Management System (TMS) Helpline after submitting routing request in TMS.
- Identify hazmat freight by selecting the "Hazmat" indicator when submitting routing requesting in TMS

Typical Products with Compliance Requirements:

- Lithium batteries, products containing lithium batteries, cosmetics, fragrances, nail polishes, aerosols, electronics, watches, paints, products requiring fuel or pressurized gas, and cleaning products
- Disposal costs are typically related to beauty items, batteries, product containing batteries, flammable items, and electronic waste (products with a cord or circuit board)

Kohl's Product Profiling Process:

UL WERCSmart handles all product profiling and safety data sheet management services for all Kohl's product which contain regulated components.

- On Kohl's Vendor Portal, vendors determine if their product is hazardous or regulated
- If a product is not hazardous or regulated, vendors must acknowledge in writing
- If a product is hazardous or regulated, vendors must access the UL WERCSmart portal and provide product information and product Safety Data Sheets (SDS).

- On the WERCSmart Portal, vendors provide key information that includes, but is not limited to:
 - SDS in Globally Harmonized System format (GHS)
 - Product Information
 - Lithium battery type, weight, power capacity, quantity
 - Fragrance volumes, container type, ethyl alcohol %
 - Product dimensions
 - Disposal/recycling information
- UL WERCSmart will evaluate the SDS and other product information to provide guidance to Kohl's on shipping and disposal of vendor products as it relates to Hazardous Materials laws and regulations by assigning a HAZ MAT code to be used in Kohl's supply chain
