

# **Procedure: Kohl's Cares Product Quality Development**

## • PROGRAM / THEME & VENDOR SELECTION

- Managed by Kohl's Cares Office
- **EXISTING** Vendors/Suppliers are responsible for following / keeping up to date on Kohl's Private & Exclusive Brand requirements posted on K-Link including:
  - Factory and Import Compliance
  - Product Testing / CPC (Children's Product Certificate) / GCC (General Certificate of Conformity)
  - Quality Assurance 3<sup>rd</sup> Party Product / Production Inspections
- NEW Vendors/Suppliers should be on-boarded prior to first orders to ensure they are approved for production and can meet/exceed Kohl's Private & Exclusive Brand product quality standards/requirements

#### DESIGN & DEVELOPMENT

- Vendor/Supplier will manage and is responsible for:
  - Matching Aesthetics to Approved Program / Theme
  - Technical Design / Construction
  - Materials Testing
  - All materials should be tested by a Kohl's approved 3<sup>rd</sup> Party Certified Lab and meet/exceed Kohl's quality standards & requirements before use in bulk production
  - Product Safety Risk Assessment
- **Vendor/Supplier** is responsible for sending product information including images to PD-product.integrity@kohls.com to assess product safety risk for the following:
  - New item development (examples)
  - Trim attachments and/or potential small parts for plush
  - Any concerns or questions regarding safety and/or quality requirements for children's products
- PI / QA teams will provide guidance and may request development samples for review
- Sampling
  - Development sampling managed by Kohl's Cares Office
  - Development samples are not required by PI / QA team unless requested

# \*It is in the best interest of Vendor/Supplier and Kohl's to address potential safety and/or quality risks during DEVELOPMENT to ensure production quality and remains on schedule

## • 3rd PARTY PRODUCT TESTING

- The Vendor / Supplier is responsible for ensuring that all styles are tested at a 3rd party testing facility
- Testing to be completed at an approved 3rd party Lab either Bureau Veritas, Intertek or SGS
- Children's test reports are valid for Tier 1- 6 months or every 100,000 units Tier 2 6 months or every 75,000units
- Testing Manuals, Protocols, Test Request Forms and Guideline can be found on K Link
- 3<sup>RD</sup> PARTY FINAL RANDOM PRODUCT INSPECTION (FRI)
  - The Vendor / Supplier is responsible for ensuring the factory provides their approved production samples (as described above) to the 3<sup>rd</sup> Party Inspection Service Provider to reference during FRIs.
  - Frequency of FRI product inspections for plush programs: Every 100K units
  - FRI will be conducted following Kohl's FRI Procedure Hardlines
