A new platform used to **exchange EDI documents** with vendors, designed to **reduce EDI errors** and **improve speed and reliability** of data in PO transmissions.



Kohl's is requiring <u>all</u> EDI traffic to flow through Orderful; allowing transactions to be viewed and validated instantly.

- No impact to the current third-party EDI provider or ASN/ Invoicing in Infor Nexus.
- The migration is free of charge for vendors, meaning no costs for migration or testing will be incurred.

Key Benefits

- Faster Vendor Set-Up & Onboarding: The self-serve platform will reduce the amount of time it takes a vendor to get set-up with Kohl's, and increase the speed in which we can get POs to new vendors.
- Peal-Time Validation: Vendors will be notified within Orderful when they have data errors, preventing them from sending bad data to Kohl's. This will reduce delays in processing goods at the DC due to data troubleshooting.
- Flexible Connection Options: Choose the connection method that works best for you—AS2, FTP/SFTP, HTTP, or VAN.
- Custom Integration Paths:
 - Integrated: Continue creating and sending transactions using your current integrator, mapper, or EDI provider.
 - Web EDI: Create and send transactions manually using Orderful.
